

## **AVALON BEACH RSL CLUB LTD – 2021 MEMBERS BADGE DRAW JACKPOT – TERMS & CONDITIONS**

The members Jackpot Draws consists of two opportunities to win a prize every Friday, the “Members Badge Draw Jackpot Prize” & the “Badge Draw Bonus.” This promotion in an ongoing club promotion.

### **1 – GENERAL TERMS & CONDITIONS**

- 1.1 - Management, Staff & Promotional Contractors of Avalon Beach RSL Club Limited are ineligible to enter both draws. Directors are not permitted to enter the “Members Bade Draw Jackpot” however are permitted to enter the 8pm “Badge Draw Bonus” draw.
- 1.2 - Open to all financial members of Avalon Beach RSL Club Ltd. over the age of eighteen (18) years who are not suspended or cited from the venue.
- 1.2 – In unforeseen circumstances management have the right to cancel or postpone the cash draws at any time.
- 1.3 - To claim any prize, members must produce their membership card as proof of current membership and/or one other form of valid identification. Valid ID includes Driver’s License, Proof of Age Card & Pensioner Card.
- 1.4 - All members financial as per Avalon Beach RSL Club’s Ebet membership system at 5pm on Friday each week will be eligible for the Jackpot draws.
- 1.5 – If proposed prize money is greater than \$2,000 the prize winner must be paid the amount exceeding \$2,000 by a crossed cheque made out to the winner (or by EFT if the winner so requests.) The full prize amount can be paid in this manner if desired. If EFT payment method is chosen, this will be completed within seventy two (72) hours of the draw.

### **2 – BADGE DRAW BONUS TERMS & CONDITIONS**

- 2.1 - The badge draw bonus winner is guaranteed to win either a \$500 cash prize or 10,000 member points (value \$100) each week.
- 2.2 – The chances of the badge draw bonus prize winner getting the \$500 cash is 1 in 3. The member drawn selects from 3 boxes to determine the prize won each week. The duty manager who opens the venue on Friday changes the location of prizes in the boxes each week.
- 2.3 - The only week where the bonus draw is not be won, is when the Badge draw jackpot prize has reached \$5,000 and is not won in the first five (5) random number generated draws. In this circumstance, the bonus draw will be for the \$5,000 jackpot prize and there will be no further draws.
- 2.4 – The badge draw bonus is drawn at 8pm. The member must be on site when prize is drawn and claim the prize within four (4) minutes. If the prize is not claimed within four (4) minutes another entry is drawn. There will continue to be draws until the prize is won.
- 2.5 – The badge draw bonus prize winner is selected blindly but the promotional staff member drawing a ticket from a Perspex barrel or box.
- 2.6 – Badge Draw Bonus Entries can be earned via the kiosk every Friday from start of trade until the 8pm draw time.
- 2.7 – Extra entries can also be earned during the week in form of a prize from the welcome kiosk or club app.
- 2.8 – Entries are earned by swiping a valid membership card at the welcome terminal located in the club reception.
- 2.9 – It is the members responsibility to collect and retain any bonus tickets won throughout the week and place in the barrel on Friday, the day of the draws.

### **3 – MEMBERS BADGE DRAW JACKPOT PRIZE TERMS & CONDITIONS**

- 3.1 - A random number generator (membership program) is programmed to draw a membership number from the current financial club membership listing, as of the date of the draw.
- 3.2 - The draw will be conducted on Friday’s at 6.30, 6.45, 7:00, 7:15 & 7:30pm.
- 3.3 - The holder of the membership number drawn must be in the Club at the time of announcement, and they then have four (4) minutes to claim their prize. They must present their membership card or acceptable identification to claim the prize.
- 3.4 - If the 6.30pm draw prize is unclaimed, a further draw is conducted at 6.45pm. etc.
- 3.5 - The initial starting prize is \$1000.00. If the initial starting prize is unclaimed the amount will then increase the following week (s) by \$500.
- 3.6 - The maximum prize is \$5,000.00.

3.7 – If the jackpot draw is won at either 6.30, 6.45, 7:00 or 7:15 there will be no further jackpot draws, however there will still be the 8pm badge draw bonus.

3.8 - Once the jackpot reaches \$5,000.00 it will remain at \$5,000.00 until it is claimed. On the night of the Badge Draw Jackpot, if the draw is not won at the regular draw times of 6.30, 6.45, 7:00, 7:15 & 7:30pm. The prize will be selected from the “Badge Draw Bonus” barrel. One (1) Member will win the \$5,000 cash prize. The winner will have four (4) minutes to collect their prize. If the prize is unclaimed, the barrel draws will continue until a winner is drawn. The barrel will be a transparent Perspex barrel or box that must be spun or adequately resorted before each draw.

3.9 - On the Jackpot Night if the \$5,000 draw is won at any of the five (5) random number generated draws, there still will be a badge draw bonus draw at 8:00pm.

3.10 - After the jackpot has been won, the prize will start at \$1000.00 the following Friday.

#### **4 – GENERAL TERMS & CONDITIONS APPLICABLE TO ALL CLUB PROMOTIONS**

4.1 - The Club’s premises are as determined by the Club in its discretion and comprise all areas within the main club building (excluding function rooms if in use for a private event at the time of the draws). The Club’s car parks does not form part of the Club’s premises for the purposes of Club promotions.

4.2 - The Club’s promotional stand (for announcements of all draws) is determined by the Club in its discretion at the time of the draw.

4.3 - The Club may require a winner to sign a legal acknowledgment, release and receipt in conformity with these conditions and in a form reasonably required by the Club, in order to be paid a prize.

4.4 - The Club in its reasonable discretion may (but is not obliged to) cancel, suspend, terminate, modify or adjourn the promotion or any or all draws or any or all processes for the selection of any winner, where circumstances unexpected by the Club arise in relation to the promotion or a draw. Unexpected circumstances could include (but are not limited to) technical difficulties, power outages, infection by computer virus, computer bug, tampering, unauthorised intervention, fraud, technical failures or errors, and any other unexpected circumstance beyond the reasonable control of the Club which corrupts or affects the administration, security, fairness, integrity or proper conduct as planned of the promotion. The Club’s rights are subject to any direction given under any relevant legislation or in connection with any permit under which the promotion is conducted.

4.5 - The Club’s decisions in relation to the promotion may be made by the Club’s CEO or his delegate or delegates from time to time (who may but need not be a Club executive), including decisions in relation to the appointment of a judge or judges in relation to the promotion or a particular draw or draws. The Club’s CEO also may (but is not obliged to) appoint one or more scrutineers for a particular draw or draws or all draws or a prize process or all prize processes. Decisions by the Club’s CEO, and subject to any countermanding decision by the Club’s CEO also decisions by any such delegate or judge, are final. No such decision requires any consultation. No correspondence will be entered into in relation to any such decision.

4.6 - Members wishing to be sure of entry should seek to complete transactions and to initiate ticket printing early, to reduce the risk of being excluded because of any shortage of service points or because of delay, crowding or venue capacity being reached.

4.7 - The Club is not responsible for, and is not obliged to delay a draw or a process of selecting a winner because of any delay or impediment in connection with the admission of members or in the completion of entries to the promotion or in seeking to attend any draw or to attend the process of selecting a winner.

4.8 - Further, the Club is not responsible for members being located in areas within the Club’s premises in which PA announcements are not able to be heard, nor for the audible integrity of those announcements.

4.9 - A prize will not be awarded or paid where in the Club’s reasonable opinion it arises as a result of a machine or other technical malfunction.

4.10 - The Club has no liability for acting on or promulgating any incorrect or inaccurate information, due to any error to any equipment or programming associated with or utilised in the promotion or any technical error or error by any third party.

4.11 - Prizes are strictly not transferable or negotiable.

4.12 - If the Club in good faith awards or pays a prize to someone appearing to the Club to be the prize winner, then to the maximum extent permitted by law that award or payment fully discharges the Club from all liability to the actual prize winner in relation to that prize.

4.13 - Tax and financial implications may arise from winning a prize and winners should seek independent tax and financial advice before accepting. The Club is not responsible for any such advice.

- 4.14 - No member is required to participate. Participation in the promotion is solely at the option of individual members. Members should not participate unless they are satisfied that they completely understand the way in which the promotion operates and these conditions.
- 4.15 - These conditions cannot be varied for an individual member.
- 4.16 - The Club determines the designated clock from which draws are timed.
- 4.17 - A person by claiming or accepting a prize agrees that the Club may use their name, suburb, photograph, image and likeness for the purpose of promoting the Club and agrees to co-operate with the Club to allow their photo to be taken for those purposes.
- 4.18 - Neither the Club nor any of its officers, employees, contractors or agents, has any liability for any loss or damage of any nature or for injury or death, sustained in connection with the promotion or any prize, except any minimum liability which cannot be excluded by law (if any).
- 4.19 - All risks of loss of or damage to any prize consisting of a car or other goods, pass to the winner immediately the Club delivers the prize to the winner. It is strongly recommended that the winner make their own arrangements for all appropriate insurances in relation to a prize to take effect from the time of delivery, against loss or damage, claims by others and any other risk of concern to the winner.
- 4.20 - Members will be notified of this promotion via the Club's advertising platforms, PA announcements, or by other means at the Club's discretion.
- 4.21 - Pictures, descriptions or other representations of any proposed prize, are general and indicative only. The actual prize will be a similar but not necessarily identical vehicle or other item, which may be an older or newer model and may be lacking in, or have different, particular qualities, specifications and accessories.
- 4.22 - In the event that any prize is unavailable, the Club reserves the right to substitute a similar but not necessarily an identical prize, of equal or greater value. 4.23 - The value of any prize (if stated) is only an approximate retail value in Australian dollars at the date the promotion is first launched.
